Dear Ms Thomson

Thank you for your email of 18 September 2019 regarding Namoi Unlimited's suite of recommendations to address the impact of drought. I apologise for the delay in responding.

As the Member for Maranoa, I have seen first-hand the devastating and far-reaching impact drought is having on farmers, farm families and regional communities. I am aware the Namoi region is one of the most drought-affected areas in Australia, and I commend the role Namoi Unlimited plays in building strategic partnerships and providing a coordinated response to drought across its member councils.

Thank you for sharing Namoi Unlimited's short-term and medium-term recommendations to ease the impact of drought, build capacity to recover and foster resilience. I understand that representatives of Namoi Unlimited met with the Hon Mark Coulton MP, Minister for Regional Services, Decentralisation and Local Government to advocate for additional drought funding for the Namoi region on 24 October 2019. I also note that the Hon Ben Morton MP, Assistant Minister to the Prime Minister and Cabinet, has already provided a comprehensive response to your correspondence. I will update and build on the information provided in that correspondence.

The Australian Government is taking action to meet the needs of drought-affected farmers, small businesses and regional communities. This action comprises a range of carefully considered short and long-term strategic assistance measures to help farmers doing it tough, and regional stimulus components to keep bush towns alive now and grow their financial viability and community vibrancy into the future.

All the Local Government Areas (LGAs) in the Namoi Unlimited Joint Organisation of Councils are eligible to apply for \$1 million under the expanded scope of the \$128 million Drought Communities Programme (DCP) Extension announced in November 2019. The new and additional DCP Extension funding will deliver community driven infrastructure projects that will create employment and keep money flowing through local shops and suppliers.

The DCSI provides \$3,000 cash payments to support farming families to cover urgent bills such as food, petrol and utilities. The DCSI is available now through The Salvation Army and the St Vincent de Paul Society.

The Rural Financial Counsellor Service (RFCS) can help farmers in the Namoi region understand their financial position. The RFCS offers free, independent and confidential counselling tailored to individuals and farm-related businesses suffering financial hardship because of the drought. The RFCS can also refer eligible people to other professional services including accountants, agricultural advisors, education, or counselling. For more information please visit <u>www.agriculture.gov.au/ag-farm-food/drought/assistance/rural-financial-</u> counselling-service.

I note your comments about extending the scope of the eligibility criteria for drought loans to include small business. In November 2019, as part of the Government's next step of drought assistance measures, we announced a new program for small businesses dependent on agriculture. Delivered by the Regional Investment Corporation, this initiative offers loans up to \$500,000 for businesses to pay staff, buy equipment and refinance.

The Government is investing an additional \$25 million to help our farmers combat pest and weeds in recognition that the risk of weed invasion, and their impacts on farms and the environment, increases significantly during drought. This funding will be complemented by the next phase of the National Landcare Program that provides a \$1 billion investment over a period of five years out to June 2023. This investment will protect and conserve Australia's ecosystems and support the productive and sustainable use of these valuable resources.

Finally, please be reassured that supporting farming families and rural communities hit hard by drought is a key priority for this Government. I am fully aware that drought places both economic and emotional stress on farm families, and the financial viability and social fabric of agricultural dependent regional communities. I am extremely proud of the resilience shown by Australian farmers and I am fully aware that farmers and rural and regional communities need support to face this challenge.

Thank you for taking the time to share your Namoi Unlimited's drought initiatives with me. I trust this information is helpful to you.
